

1. Aims

The Certificate II in Music Industry course is designed to give people opportunity to develop skills and knowledge related to the music industry. The course will train individuals in music performance, composition and technical production in a Christian context. This course is normally delivered in a range of contemporary music genres such as pop, rock, gospel, folk, blues and jazz.

2. Program Summary and Employment Outcomes

This course will provide training in practical skills and background knowledge related to the music industry. More specifically the course focuses on practical skills development, knowledge of music theory, performance as well as providing general training in music industry areas such as copyright and work, health safety.

Course outcomes apply to both paid and voluntary employment options. More specifically this course aims to give students the opportunity to achieve the following outcomes:

- Musician/Singer
- Band Member

This course is delivered in a Christian context and will provide knowledge and skills relevant for involvement in a church or Christian ministry organisation, or any other work context which requires relevant skills.

3. Overview

This course is fully competency based and while knowledge and some aspects of competency are assessed within the realms of each subject, completion of practical activities demonstrating all areas of competency will need to be completed to graduate.

A part time student would normally undertake a study load of 1-2 subjects at any one time. Individual subjects may be delivered on a twice monthly basis, by intensives or by correspondence.

4. Duration

The Certificate II in Music Industry course would usually be completed over a period of 6-12 months on a full time basis. The course may be studied part time.

5. Costs 2021

6. Entry Requirements

General requirements for entry are:

- A completed student application form & payment of the application fee
- A pastoral reference (not required for school students)
- A demonstrated interest/involvement in the music field
- Minimum entry age is 14.
- Students should have basic computing skills including the ability to use a word processing package at an elementary level.

Students should in good conscience be able to subscribe to the ethic of Unity College Australia and any partner college which implements the course. These centres are based on mainstream Christian values. This means that students will:

- respect those who hold Christian values
- respect college authority and other students
- respect college and student property
- comply with cultural and social standards including:
 - modesty of dress
 - honesty and integrity in dealing with others
 - sensitivity to students from cultures different to one's own
 - no consuming of alcohol or non-medicinal drugs, nor being under the influence of the same, while on campus. The college is a non-smoking environment.

7. Training Process

This course involves approximately 2-4 hours per subject per week and may be studied on a part time or full time basis. The implementation of this course varies depending on the context and location. More details are available on request to the National Office or campus coordinator.

A wide variety of training methods is used. Training may be delivered through:

- lectures, presentations and demonstrations
- interactive discussions
- group participation
- individual tutorials
- master classes
- practical skills exercises
- distance education
- individual projects
- research into literature and other resources
- audio/visual presentations
- visits to local Christian ministry centres
- visits to artistic performances and exhibitions
- use of guest speakers
- role plays and simulations

Unity College Australia adopts adult-learning principles, and all students are treated as adult learners. Participants in this program are therefore expected to take charge of their own learning process. It is expected that each selected participant will be committed to meeting the requirements of the relevant course and will attend relevant classes and activities and complete all work required for assessment.

8. Course Competencies

Australia has a system of national standardisation of training for many industry areas including Music. This system is implemented through the use of training packages (groups of courses) and individual units of competency. Students are able to get automatic recognition across all accredited government and private training organisations for relevant studies undertaken at any one of them.



All competencies studied in each of these courses are nationally recognised competencies from the CUA Training Package (Music Industry).

Graduates will be issued with a statement of competencies achieved as part of their studies. Individual nationally recognised competencies linked to subjects in this course are listed below

9. Course Structure

The course consists of 8 units. Core and elective subjects are listed below. Students are required to complete all 3 core subjects as indicated and 5 elective units.

10. Assessment overview

- completion of rehearsal schedules
- written assignments, exercises, tutorial/seminar presentations, tests as applicable
- journal/process diary completion as applicable

Competency-based assessment criteria apply to grading. The final Academic transcript will show the following results for each subject.
